AT the Court at St. James's, the 9th Day of No. wember, 1759,

PRESENT,

The King's most Excellent Majesty in Council.

HEREAS the Time limited by His Majesty's Proclamation of the 15th of May last, "For giving Encouragement to Seamen and able bodied Landmen to enter themselves on board His Majesty's Ships of War; for granting Rewards for " discovering such Seamen as shall conceal them-" felves; for pardoning fuch Seamen as have desertdeferted and shall return into the Service; and also for " taking up all stragling Seamen," hath been prolonged and extended to this Ninth Day of November, And whereas it is judged expedient for His Maiesty's Service, that the same should be continued for some Time longe:-His Majesty doth therefore, by and with the Advice of His privy Council, hereby Order that the faid Time be prolonged and extended from this Ninth Day of November, to the Thirty-First Day of December next, and that the Bounties and Rewards given and granted by His Majesty's aforementioned Proclamation, be continued to be paid until the said Thirty-First Day of December next-Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

A T the Court at Kensington, the 23d Day of October, 1759,

PRESENT,

The KING's most Excellent Majesty in Council.

HEREAS the Time limited by His Majesty's Order in Council of the 14th of April last, for prohibiting the Exporting out of this Kingdom, or carrying Coastwife, Gunpowder, Salt Petre, or any Sort of Arms or Ammunition, will expire upon the 20th Day of this Instant October.—And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition should be continued for some longer Time.-His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, Require, Prohibit and Command, that no Person or Persons whatsoever (except the Master General, Licutenant General, or Principal Officers of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the faid 29th Day of this Instant October, preseme to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder, Salt Petre, or any Sort of Arms or Ammunition, or Ship or Lade any Gunpowder, Salt Petre, or any Sort of Arms or Ammunition, on board any Ship or Vesial, in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first obtained from His Majesty or His Privy Council, upon Pain of incurring and suffering the respective Forseitures and Penalties inflicted by an Act passed in the Twenty-Ninth Year of His Majesty's Reign, entituled, "An Act to impower His Majesty " to prohibit the Exportation of Salt Petre, and to " enforce the Law for impowering His Majesty to

" prohibit the Exportation of Gunpowder, or any " Sort of Arms or Ammunition, and also to empower "His Majesty to restrain the carrying Coastwise of "Salt Petre, Gunpowder, or any Sort of Arms or "Ammunition." And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great-Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain.
