At the same Time that we express the high Sense we have of these invaluable Blessings, we beg Leave to affure your Majefty, that it shall be our constant Study to inspire the Youth under our Care with just Impressions of those valuable and distinguished Privileges, which this Nation enjoys under the Government of so great a Prince, and of so wise an

Administration.

We pray, that your Majesty may be long preserved; that wise and faithful Counsellors may be still placed about your Throne, and that your Name may be transmitted to latest Ages, as the Defender of the Protestant Religion, as the Guardian of the Liberties of Europe, and as the indulgent Father

of a Free and a Happy People.
